## Concord Oval Recreation Centre Futsal Competition Player Code of Conduct & Terms and Conditions

## Player Code of Conduct:

- By registering in our futsal competition, I agree to the below Player Code of Conduct:
  - o I will play according to the Concord Oval Recreation Centre (CORC) Futsal By-Laws.
  - o I will refrain from swearing or using foul, abusive, or derogatory language.
  - o I will not verbally abuse (language, comments and words that threaten) a player, referee, spectator or Concord Oval Recreation Centre staff member.
  - o I will not argue or dispute a referee's decision.
  - o I understand that Concord Oval Recreation Centre has a zero-tolerance policy on any behaviour deemed to be excessively aggressive or antisocial.
  - o I understand that Concord Oval Recreation Centre has a zero-tolerance policy on violent conduct.
  - o I will not arrive at the Concord Oval Recreation Centre under the influence of drugs or alcohol.
  - I will refrain from any action deemed, in the ultimate discretion of the referee or Concord Oval Recreation Centre staff, to bring the game into disrepute or any other action which is not in the spirit of the game.
  - o I will respect the rights, dignity and worth of all participants regardless of their gender, ability, cultural background, or religion.
- Should a player (or team) breach the above Player Code of Conduct, CORC may take whatever action
  necessary including but not limited to suspension of individuals and teams; individual bans or team
  bans; escalating the matter to Police or appropriate law enforcement bodies.

## Terms and Conditions:

- I give permission for photographs or videos showing images of me and my child/ren to be taken whilst we are at the Centres. I also give permission and consent to the photographs or videos showing images of me and my child/ren to be used at the Centre's sole discretion for the purposes of internal and external communications, which may include but not limited to advertising and marketing, email marketing, posting on the Centre's official social media account(s) including Facebook, Instagram and Website. I understand that I can withdraw the above consent at any time by advising the Centre in writing.
- By becoming a user of Five Dock Leisure Centre and Concord Oval Recreation Centre, I agree to receive email communication from the Centres. I understand I can unsubscribe at any time.
- I acknowledge that at all times that I am on the premises known as Concord Oval Recreation Centre for the purposes of undertaking an activity which is organised, approved or endorsed by Concord Oval Recreation Centre or Canada Bay City Council, both my person and property are at my own risk.
- To the fullest extent permitted by law, I hereby release Canada Bay City Council, Concord Oval Recreation Centre, its directors, employees, agents, contractors, spectators, volunteers and sponsors, from all claims and liability of all nature (including the negligence of any such persons) arising directly or indirectly by my participation in an activity which is organised, approved or endorsed by Concord Oval Recreation Centre or Canada Bay City Council (including indoor sports programs, exercise or gymnastics programs)and whether prior to, during or following the completion of such activity.
- I warrant that I am physically fit and able to engage in the exercise and indoor sports programs.



## **Injury Insurance Information:**

- A player must be registered in the current CORC futsal competition to make an insurance cover claim.
- All registered players agree to be covered by the sports insurance policy as arranged by CORC. Policy details are available from the competition organiser via <a href="mailto:recsportsprograms@canadabay.nsw.gov.au">recsportsprograms@canadabay.nsw.gov.au</a>.
- For a player to make an insurance claim, an injury report form must be completed within 14 consecutive days of the reported injury. Failure to do so may void a player's right to claim through the above-mentioned insurance policy.
- Please note that CORC provides the minimum level of cover which means this program is not "comprehensive" and as such, we encourage all participants to take out private health, life and income protection insurance according to their own individual needs and circumstances.
